### **PRESIDENT'S MESSAGE**

We have the pleasure of presenting this Annual Report for the year 2015-16. As we review the year that has just passed, thoughts go back to the beginning of this organization in 1970. Back then, orphaned and abandoned children were growing up in an institution and facing a gloomy future. With a firm belief that the child needs love, nurture and security of a stable family that would be available through adoption, the founders of this Association strived to make adoption a socially accepted and a legally secure practice countrywide. Following the first eventful twenty five years of determined efforts on several fronts, the aim of building families was extended to children at risk of losing care of their family or deprived of education due to family's inadequate resources.

Over the forty five years, this organization has grown and extended, learning from experiences and responding to the changing social scene. Significant among the recent changes that have come about at the national level is the introduction of the Integrated Child Protection Scheme (ICPS) and the latest legislation, the Juvenile Justice (Care & Protection of Children) Act 2015. These developments mark the government's changed approach to converging services for children in need of care and protection. This in itself is a very welcome development, and reflects the approach that we have taken over the years in developing our various programmes and services.

In the area of adoption, the official Adoption Guidelines 2015 centralizes adoption of children nationwide through an Online system. It depends heavily on the electronic communication, including selection and matching of children and prospective adoptive parents digitally. This has created concerns in the adoption work, as described later.

Bal Sangopan Yojana (BSY) that aims at preventing family disintegration, with timely supports is a Maharashtra State initiated scheme. IAPA is one of the agencies implementing the scheme so that the child is not neglected or separated from the family in crisis situations. During the year under

review, support received from the H.T. Parekh Foundation has enabled IAPA to reach out to additional children raised by a single parent and those affected by AIDS. In the Educational Sponsorship programme, a progressive change has been witnessed in the aspirations of children in pursuit of education and preparation for promising careers, as narrated later.

During recent years, the Rural Sponsorship programme that is centered in the School in Terewayangani has expanded considerably. Catering to the Secondary School level students from the cluster of five villages, its work has now extended to girls and women, with the active support of the 'Chance of Life' organization based in Germany. Over the years, the main contributor has been TdH Denmark; and individuals who have enriched the programme with their personal involvement and financial contributions.

Various other services that compliment the main programmes are contributing to enhancing the child's coping capacities to achieve all round development.

Supports received from our long cherished donors, namely, Chatwani family, 'Terre Des Hommes' Denmark, 'Chance of Life Germany', and our collaborator, the N.M. Budhrani Trust with many more Corporates, Trusts and individuals mentioned in this report later, have made it possible for us to pursue our goals. We owe our Deepest Appreciation to them. Our sincere thanks to our dedicated staff for their commitment to the cause.

#### **FOSTER CARE & ADOPTION**

#### For the child without parental care

Recognizing the importance of family for healthy growth of a child the Adoption and Foster Care programme (initiated from inception) focuses on family care services for children deprived of a family. Securing a permanent home for a child include a host of services for the stake holders viz. the child, the birth parents, foster parents, adoptive parents and the adoptee, liaising with various authorities along with advocacy awareness building and publicity programmes.

#### **FOSTER CARE SERVICES**

Departing from the established practice of care in an institution for the child who is abandoned, orphaned or given up by the birth parent/s for social reasons, IAPA chose the option of care of children in a foster family. This ensures close personalized care of the child 24 / 7, so vital for the child's nurture and development. The child remains in the family until his / her permanent rehabilitation is achieved. Most of the children find forever homes through adoption. The few, who are unadoptable due to their very special needs, continue to be fostered or placement in alternate long term care in a children's home is sought, with ongoing IAPA support.

#### **FOSTER FAMILIES**

Foster families are selected for their ability to provide quality and tender loving care to a child and who fulfill the criteria laid down by the government. They attend to the child's physical, emotional and social needs, under close monitoring of the agency. The child blooms under the special bond that develops during the foster care period. Foster parents are prepared for the eventual departure of the child. The vacancy is replaced by another child.

Most of the foster families have been associated with IAPA over a long period of time, resulting in developing a special bond. Our foster families have become an integral part of the IAPA family. Kudos to their dedication and yeoman service!.

**Ten** foster families looked after **23** children during the year.

#### **ADOPTION**

New Adoption Guidelines were introduced by the Central Adoption Resource Authority (CARA) in August 2015. Under these guidelines the adoption process has been centralized through an online system. Processing adoption applications, which was done by adoption placement agencies is now done through an electronic processing system. The new procedure is aimed at avoiding multiple registrations, and facilitating a quicker, transparent process.

The new system has put stringent timelines in place, which at times could pressurize the Prospective Adoptive Parents (PAPs) into making hasty decision about selecting a child. Further if the PAPs say no to a child, they might have to wait a long time before another suitable child is referred to them. Moreover, PAPs have to travel long distances to see the child, proposed from a pool nationwide.

The online system conflicts with the provisions of the Juvenile Justice (Care and Protection of Children) Act, 2015 that later came into force on January 15th 2016. The Act does not mandate the online process. This contradiction has been challenged by the Federation of Adoption Agencies, Maharashtra amongst others in the High Court, Bombay. The change in the system notwithstanding, IAPA continues to engage in providing mandatory services to various stakeholders in the adoption process. These include providing Information and Guidance about adoption procedures. There were enquiries by phone, emails, and walkins. The adoption team was involved in providing preadoption counseling, attending to selection procedures and legal formalities, follow up, assistance in obtaining birth certificate and post adoption guidance.

Crucial to the process is also providing guidance and support to birth parents, liaising with the hospitals, police and the Child Welfare Committee (CWC) for scrutiny and free for adoption orders.

# FOSTER CARE AND ADOPTION STATISTICS

- Of 23 children in foster care 5 children continued to be on roll from the previous year out of which two children are with special needs. Of the 18 new referrals 10 were girls and 8 boys coming under our care, families were busy fostering children with their varied needs
- IAPA received **25** online requests from PAPs for home studies. **16** home studies were completed
- 15 children (10 girls and 5 boys) from IAPA's foster care were placed in adoption. 14 were placed within the country and one was placed inter-country. 12 placements were legalized.
- Five children from other agencies were placed with families serviced by IAPA

#### **FAMILY MEET**

The Annual Adoptive Family Meet was held on Saturday 6th February 2016. As in previous years, a few enthusiastic Adoptive Parents were involved in planning and sponsoring the Meet along with the IAPA team. The yearly event provides a platform for parents who have adopted as well those proposing to adopt, and foster parents, to interact, share experiences and draw lessons from each other.

A colourful theme was set for the Meet which presented the venue with vibrancy. Goodie bags sponsored by few adoptive parents were given as welcome gifts to the children.

An engrossing magic show and games for families held everyone captive. The grand finale of the evening was a ramp walk by the mothers and children with crowns/ tiaras made by the mothers from straw.

One of our adopted youth (in his early 20s now) sprang a pleasant surprise with his presence at the Meet. Reconnecting with him was yet another delightful moment for all at IAPA.

#### **COUNSELLING IN ADOPTION**

IAPA offers counseling service for pre- and post-adoption challenges and problems. Dr. Laura Vaz, a psychotherapist, assisted by a social worker provided her expertise using the Cognitive Behaviour Therapy.

During the year 2015-16, **7** families approached IAPA for counseling. These were all post adoption cases where the adopted children/young persons were in the age group of **5** years and **25** years. The concerns and issues focused around

- The child's behavior
- Parenting style
- · Concern over child's academic growth
- Concern over child sexual behavior
- Relationship issues

#### **ROOTS SEARCH**

Adopted children do experience the need to know about their origin. Some approach the agency to seek information on the background / circumstances and reasons for being given up. Three such requests were received this year. Though meeting the birth mother was not possible, in two cases the adoptees were assisted in meeting their respective foster mother. Connecting with them was a hugely fulfilling experience as it filled a void in their early life.

#### **CAPACITY BUILDING/ SENSITIZATION**

During the year, IAPA was engaged in sensitization and capacity building of various stakeholders in the processes and procedures for implementing the new Adoption Guidelines.

#### SAKAR and Love Trust Specialised Adoption Agencies

All the Specialised Adoption agencies (SAA) under the new system are now allowed to process both in-country and intercountry adoption cases. The Love Trust from Buldhana and SAKAR from Aurangabad that had channeled their intercountry cases through IAPA earlier sought guidance in independently processing such cases. The representatives of SAKAR visited IAPA to familiarize themselves with the requisite procedures, documentation, and legal obligations. The Love Trust continues to consult IAPA from time to time in this regard.

#### Aangan India –

Aangan (working in the area of Child Protection) was invited by the Department of Women and Child Welfare, Uttar Pradesh (UP) to conduct divisional level training on Adoption. IAPA was approached to conduct the training in three divisions of UP. The main objective of the training was to provide knowledge, information and skills to ICPS personnel and CWC members in respect of their roles and responsibilities vis-a-vis the August 2015 Adoption Guidelines. Ms. Savita Nagpurkar, Adoption-in-charge conducted the training for two groups from 11th to 13th March 2016. Ms. Smita Zankar, Manager – Resource Mobilisation conducted the training for one group on 28th and 29th March 2016.

# FAMILY PRESERVATION & FOSTER CARE ASSISTANCE

(Kinship Foster Care For Children In Crisis)

#### **CHILDHOOD MATTERS**

Family Life is critical for a child wherein the physical and emotional needs are met for normal growth and development. Families fraught with crisis are handicapped in fulfilling their obligations to meet them. To prevent neglect, separation and institutionalisation of the child, IAPA initiated other family based services aimed at family preservation and strengthening and sustaining the child's education.

Institutionalisation is an option families resort to in crisis situations such as loss of parents, desertion, illnesses like debilitating diseases of HIV, TB, cancer. Institutional care deprives the child of family support and personalized love and care. It is in this context that the foster care programme, a non-institutional service assumes significance.

The Kinship Foster Care program of IAPA is supported under the Bal Sangopan Yojana, a Government of Maharashtra scheme and H.T. Parekh Foundation, a CSR initiative of HDFC Ltd.

#### **BAL SANGOPAN YOJANA (BSY):**

The Maharashtra Government formulated a Foster Care Scheme Bal Sangopan Yojana in 1995. IAPA is one of the designated NGO's which is implementing the scheme. Prevention of institutionalization has been the main thrust of the scheme. The programme caters to children facing neglect from their family undergoing crisis. Possibilities of alternative care with an extended family member are explored. Financial assistance is given towards the maintenance of the child.

In addition to this children of single parents who are struggling to take care of the child are also given financial assistance. In certain cases the child is also looked after by an unrelated foster family like neighbors and acquaintances known to the child wherein the child feels a sense of belongingness. IAPA was sanctioned a quota of 85 children-orphaned, destitute, of single parents or having both parents. Both girls and boys attending school and college received financial help.

Grant of Rs. 8,12,780/- was received during the reporting year under this scheme from the Maharashtra Government.

#### H.T. PAREKH FOUNDATION

The growing demand from families to supporting more children in Kinship Foster Care was supported by the H.T. Parekh Foundation, a CSR initiative of HDFC Ltd. This project which started in year 2014 with 50 children is now supporting 100 children.

Through this project IAPA provided support to vulnerable children (orphans, destitute, of single parents and both parents HIV positive) in the communities of Wadala and Reay road areas. This has become possible with the initiative of Angan Trust who has been closely working with these communities.

#### **REFERRALS**

In few cases, where families seek institutional care for the child due to some crisis, IAPA's intervention is sought by the Child Welfare Committee (CWC) to explore the alternative of kinship foster care. IAPA acting as a gate keeper at the time of referral counsels and guides the family to consider the option.

Referrals also come from schools, hospitals and NGOs. The cases are reviewed annually and reports on the progress of child and family are submitted to the CWC.

IAPA has also come to the aid of child headed families,

wherein the eldest sibling who is herself a child 16 or 17 year old has taken over the role of family head after the death of both the parents. This has allowed the siblings to remain in a closely knit family atmosphere thus preventing the disintegration.

In addition to providing financial assistance, enhancing the child's emotional and social competence and rehabilitation and strengthening the family has been of paramount importance as addressed through a host of supportive services mentioned later.

#### **CONSULTANCY**

In recognition of IAPA's experience in advocating the foster family care programmes, Mrs Kaumudi Telang, President, IAPA was invited for a National Consultation on formulation of Foster Care Guidelines, organized by the Central Ministry of Women and Child Development on 3rd June 2015.

# SPONSORSHIP FOR EDUCATION & DEVELOPMENT For the underprivileged child

IAPA's Educational Sponsorship Programme since its inception in 1995 continues to facilitate and promote education of students from low Socio-Economic strata. Operating from its Project office in Khetwadi, it reaches out to children studying in Municipal and some private schools in the B, C, D and E wards of Mumbai.

The monthly financial aid along with counselling, professional guidance, medical help, and host of support services enabled in sustaining *516* children in the educational mainstream. It is a proud feeling for IAPA to see many students aspire for higher education and professional courses. The sponsorship aid to the students was received from Individual sponsors, Trusts and Funding organizations within and outside the country.

#### **OUR PROJECTS & SPONSORS**

#### TERRE DES HOMMES (TDH) Denmark:

One of our earliest sponsors they continue to support our children in many ways. The project which started in 1997 with sponsorship help for **40** children is now supporting **126** students. Out of these **29** students cleared their Board (Secondary, Higher Secondary and Graduation) exams. **10** students secured distinction and first class marks.

Shailesh acquired Bachelor of Science (information technology) qualification and has started working on a temporary basis in an IT company. He is hopeful of getting absorbed permanently in this job. He hails from a poor socio-economic background. His father did the rounds of distributing newspapers, and his mother worked as a domestic help.

#### THE JAMNADAS & KANTABEN CHATWANI SPONSORSHIP PROJECT:

This project also started in 1997, with assistance from the Chatwani family, United Kingdom provided financial aid to **100** students.

**21** students appeared for their Board and Graduation exams, of which **19** passed.

What a feeling of pride and joy for this young aspirant who is the first female in the family to complete graduation and pursue post graduation! Reeta 20years as a young student had a weak foundation. She did not seem interested in studying, and would often miss school. Though her father had done schooling, her mother had never been to school. Appropriate guidance to Reeta's parents helped in them prodding her to attend school regularly. With input from IAPA, Reeta started developing interest in studies. In her journey, she was faced with many challenges – she overcame tuberculosis, witnessed and coped with the death of her elder sister to tuberculosis; and is now facing the challenge of helping her father cope with schizophrenia.

#### CHANCE OF LIFE(COL) Germany:

The sponsorship project which began in 2005 aims at empowering the girl child. The project now supports **104** girls. **32** girls cleared their Board exams – a very heartening outcome of this support!

Rekha has completed her graduation by scoring 72% marks in the Commerce stream. Rekha's parents are visually impaired. Her mother runs a telephone booth and manages the household. Her father does not contribute much. Rekha managed her studies and worked to supplement her family income. Despite the heavy odds she successfully completed her graduation. Now she works in a private coaching class in the administrative department.

#### **Alumni Meet**

10th October 2015 marked the first alumni meet of students receiving help from COL. Students from two other organizations receiving help from COL also participated. To everyone's amazement and joy, few students spoke of their association with the project in English. Some others gave entertaining performances through dance, recitation, and songs.

#### · INDIVIDUAL SPONSORSHIP:

The opportunity to make a difference in the lives of

marginalized children motivates several individuals to sponsor the education of one or more children. At present **81** students are being supported under the project. Of these **20** students cleared their Board exams.

Vrushali raised by her mother in difficult circumstances completed a specialized Bachelors course in Banking and Insurance and is now working.

Prasad who successfully completed his graduation in the Commerce stream is planning to study further. This has become possible due to the support of his mother the main bread winner of the family and the agency.

#### M.D.THACKERSEYTRUST:

The Trust which began its support of twenty girls in 1999 is now supporting **40** girls.

#### · LATE MEERA SRINIVASAN SCHOLARS PROGRAMME:

The project was started by Mr. T. Srinivasan in memory of his wife late Mrs. Meera Srinivasan who was keenly involved in furthering children's education and was an active IAPA supporter. 11 children are being supported under this programme. 6 scholars from these are children of our foster families.

Last year Hon. Justice Ms. R. S. Dalvi had shown keen interest to know more about IAPA's foster family care programme. During this conversation, she learned about the foster sister – Vrushali More who scored 93% marks in her SSC exams. Justice Dalvi personally met her on October 14th, 2016 in her chamber to felicitate Vrushali on her success.

#### · MUMBADEVITRUST SCHEME:

The trust is providing educational help to 10 students.

#### **Additional Support for Higher Education:**

Majority of IAPA's student beneficiaries complete their school education in vernacular medium. When in college, the medium of instruction is English, resulting in a big challenge in understanding study matter. They need support by way of tuition classes. If unable to bear the cost of fees, they tend to discontinue their studies. To help these students, IAPA has networked with the following funding sources -

#### · CAPRIFOUNDATION:

**83** meritorious students from under privileged families were provided support for their higher education through Capri Foundation, a Corporate Social Responsibility (CSR) initiative of Capri Global Ltd.

#### · AMERICAN WOMEN'S CLUB BOMBAY:

*Three* students received additional help from the American Women's Club Bombay

#### • BOMBAY COMMUNITY PUBLIC TRUST (BCPT):

BCPT with whom IAPA has a long standing fruitful association continued to support the education of *two* of our students.

Supported the education of *two* students.

Sunita Motwani and Rema Menon, our ex-colleagues and their friends have given funds to support the education of *four* students who are pursuing Engineering.

#### **ANNUAL GET TOGETHER**

The Annual Get-together of the students covered under Sponsorship, Foster Care & Asmita project was held on 26th January, 2016 at Gilderlane Municipal School. *335* students from 4th to 10th and *27* college students participated enthusiastically in this much awaited event. Students who fared well in their Board exams were felicitated. Cultural performance put up by the students was followed by a Fun Fare. The whole day event was sponsored by our long cherished benefactors Mr. Sanjay and Mrs. Priti Kapoor and family.

#### IAPA- TdH RURAL PROJECT

IAPA with the support of Terre des Hommes, Denmark continues to sustain the education of the children studying in Kamalakar Janardan Bai Javkar Vidyamandir. This is the only school providing secondary education to the students of Terewayangani, as well as the nearby villages in Dapoli of Ratnagiri District, Maharashtra. The project aims at the overall development of the students and encourages them to pursue higher education. At present *50* students are supported through this project.

In 2015 the school achieved cent percent results in the board exam of Std. X. The first *three* rank holders of the school scored between 70% and 80%. In addition *nine* students secured first class marks.

#### Supportive services/ activities-

- Extra classes are conducted after school hours for students of Std. X for four months from December to March by the school teachers. The agency provided evening dinner and morning tea & biscuits to the students. An ex-gratia was given to the teachers for their efforts.
- · Through the generous support of Mr. Shakir Machhiwala the school which had only one computer, received three new laptops to facilitate ICT learning, a compulsory subject of the curriculum.
- Students of Std. X were given six sets of reference books (21 question sets). This was made possible due to the support of Ms. Bindi Sandip.
- · Support from Mr. Mangesh Dhaimade, an individual sponsor and Terre des Hommes, Denmark helped in providing uniforms to the new students who enroll in the school in Std. VIII.
- · The constant paucity of electricity especially in the evenings affected the studies of the students. 14 sets of solar lamps by Mr. Sanjiv & Mrs. Priti Kapoor were of tremendous help.
- · Support for Higher Education: Due to the family's strained financial conditions students are forced to discontinue their education after Std. X. Many come to the city in search of a job and end up taking menial work. IAPA with the help of some donors provided financial assistance enabling the students to continue their education after Std. X.
- Apart from regular courses like Commerce & Arts students have opted for Mechanical & Chemical Engineering, Bachelors of Science in Agriculture, Industrial Training, and Chartered Accountancy. This was possible due to the support received from Mr. Noordin Ebrahim and Ms. Komal Chandiramani.
- A visit was jointly organized by IAPA and Shivneri Education Trust for students of std. VIII to X to Agriculture University and Police Station, Dapoli on 22nd January 2016. **99** students from Std. VIII to X along with teachers and social workers participated in the visit.
- Vocation and Career Guidance sessions were conducted for students of Std. X.

#### **Empowerment of girls & women**

Chance of Life (COL) Germany working for the empowerment of girls and women reached out to them to enhance their capacities and become self-reliant. A locally based social worker has been appointed to conduct the life skill sessions on a wide range of subjects. Vocational guidance and help is provided, enabling girls to pursue courses like Auxilary

Nursing and Midwifery (ANM), tailoring courses, and such others that help them secure a good job. Short term training was also conducted for twenty girls and women in making imitation jewelry, fabric, warli & glass painting, and other decorative items.

#### **COMMUNITY OUTREACH**

# **Enrichment programmes for the child &family**

Supportive services complimenting the core services are aimed at all round development of the child and the family with the objective of strengthening the family as a whole.

#### Child Guidance Centre 'Aastha':

Our Child Guidance Centre (CGC) 'Aastha' started in 2002 continues to address the mental, emotional, psycho-social and even physical problems of children as well as their family members covered under Sponsorship & Foster Care services. It also caters to other students referred by neighbouring schools.

The team consisting of Counsellor, Remedial Therapist, Psychologist and Psychiatrist function once a week.

Cases covered during the period ranged from academic issues faced by the children like lagging in studies, learning disability, hyperactivity, social adjustment, conduct disorder, sensory and motor planning programme and some psychiatric interventions for problems like bed wetting and epilepsy. Other issues dealt with emotional factors experienced by the children due to problems on the home front. In addition students were counselled about appropriate study habits and preparing for the exams.

Parents were treated for issues ranging from obsessive compulsive behavior, schizhophrenia, to advise on health problems.

#### **SESSIONS & AWARENESS PROGRAMS**

- CGC panelists conducted sessions with the teachers of West Khetwadi Municipal School, teachers of 'Asmita' and representatives of NGO 'Prerana' for addressing the issues faced by them while dealing with the children. These sessions helped the teachers to voice out their concerns and difficulties while the panelist gave them guidance on handling different problems.
- On the request of the Principal of Motishah Lane Municipal School the CGC panelists conducted a session for students of Std. IX and std. X of the school for adolescent issues. The students were also guided on how to prepare for the exams.

#### **VOCATIONAL TRAINING & ASSISTANCE**

Vocational training aims to support the students and their siblings in taking up skill development courses which equips them in securing career related jobs.

#### Courses conducted:

- · IAPA conducted Course in Basic Computer training and Tally. **60** students completed the course successfully. In January 2016 IAPA was able to refurbish the computer lab with the help of twenty new computers and two printers donated by TdH Denmark. Ms. Dina Rosenmier, Vice President of TdH inaugurated the lab.
- · **30** women were trained in tailoring skills.

#### **Courses supported:**

IAPA also financially assists the sponsored students and their siblings to take up various vocational courses like advanced computer courses, advanced tailoring, beautician, jewelry making, fabric painting, mehendi course, typing, shorthand, short term accounts courses. This has become possible due to the generous support from Chance of Life, Germany for girls and women. Last year *65* girls benefitted from the support. Similarly *six* boys were helped to take up vocational courses with the support extended by Terre des Hommes (TdH) Denmark.

#### **Medical & Nutritional Assistance:**

With the support of TdH Denmark, Chance of Life, H. T. Parekh Foundation and Individual Sponsors, financial aid towards medical needs was given to children and their family members. This help to **81** clients ensured timely treatment. Some of our children and members of their families suffering from long term debilitating diseases like tuberculosis and HIV infection were provided nutritional support thanks to the funding that came from Ms. Alpana Dange, Ms. Margaret Mehta, and Dr. (Ms.) Mangala Shenoy.

#### Micro Finance:

A sum of up to Rs. 5000/- is given as a loan to women members from our children's families to start a small scale enterprise or expand an existing one. The assistance helped them procure sewing machines for tailoring, selling merchandise such as dress material, floral garlands, snacks, cosmetics, vegetables. 12 women availed of this facility, and were successful in running the business. This enabled them to repay the entire loan amount in time. Funding for this came from Chance of Life, Germany and Hannah Programme for Women.

#### Aam Aadmi Policy:

IAPA has continued availing the benefits of the Government Life Insurance Protection policy for its clients. **47** persons enrolled in this policy by paying a nominal premium of Rs. 100/-. The policy provides for an insurance cover of Rs. 30,000/- on natural death, Rs. 75,000/- for accidental death or permanent disability and Rs. 37,500/- for partial disability.

The policy in the name of Mr. Jainuddin Shaikh was beneficial for his family after his death to a heart attack. His wife works as a domestic help, and has three school going children to support. The sum of Rs. 30,000/- brought timely relief to the family.

In addition, children of those insured under the scheme are eligible to receive yearly scholarship of Rs. 1200/- if they are studying in classes 9th to 12th standard. Last year *five* students received scholarship under the scheme.

**English Speaking Classes:** Knowledge of English has become a vital necessity in the increasingly globalised world. To equip the students with conversational English, Mrs. Radhika Ram a volunteer has been conducting English Speaking classes for the students of Std. VIII & Std. IX in IAPA from February 2016.

#### **Special Assistance:**

- Food grains Terre des Hommes (TdH) Denmark with the support of Ramboll Foundation provided funds for food grains to **126** families of its sponsored students.
- Assistance for House Repairs Sixty Five year old Nandini Ayare and her thirteen year old orphan grandson living in a dilapidated shanty was helped in refurbishing the shanty, resulting in enhanced living conditions. Financial assistance was received from Mr. Prashant Pawar and Mr. Ethan Sutaria
- Solar Lamps Mr. Sanjiv and Ms. Priti Kapoor's donation of solar lamps to *three* students brought light into their houses which had no electricity.

#### SUPPORT SERVICES

### Ongoing Extension Programmes **ASMITA:**

The programme was initiated to help the children studying in Std. I to VII of West Khetwadi Municipal School as well as those from the nearby Municipal Schools to sustain their education and work for their development through various personality enrichment programmes. It stresses on an integrated approach for the holistic development of the child.

Classes conducted outside school hours help to occupy them fruitfully while at the same time providing guidance in their studies. It lays emphasis on imparting the basics of languages like Marathi and English as well as the concepts of Mathematics to the students. Sessions on life skills, value education, yoga, dance, outdoor activities, educational visits, participation in talent competitions are undertaken for enhancing competency and personality development. Special Thanks to Mr. Sudhir Merchant for his generous support for the programme.

## IAPA – KAMAL FOUNDATION COLLABORATION

Kamal Foundation supported by Dr. Anaita Udwadia Hegde, Mr. Darius and Mrs. Nergis Udwadia provides financial and medical intervention for children suffering from critical neurological conditions. IAPA's help is sought to assess the family's economic background and need through home & hospital visits and follow-up. In all 62 children received help under this programme.

#### IAPA - NARAINDAS MORBAI BUDHRANI TRUST(NMBT) VALUE EDUCATION PROGRAM:

The collaborative Value Education Programme (VEP) which began in 2014-2015 after a successful pilot study, continued this year too. There was an increase in the number of schools covered from thirteen to twenty. Students from 6th to 8th standard from schools in Malwani, Charkop, Gorai and Iraniwadi have reaped the benefits of the programme.

The programme was effective in inculcating positive values through topics of goal setting, time management, organization of skills, honesty, and friendship. In this manner students were prepared to face the world with positive energy within them. Follow up has indicated remarkable, constructive impact on the lives of the students.

In addition to the VEP, individual and group counseling sessions were conducted to help children cope with learning issues, emotional disturbance and stress management.

Students presented their learning from the VEP sessions through role play and skits. A 12 days summer camp was organized for students in three schools with the objective of enhancing their Creative and Critical thinking.

#### STUDENT PLACEMENTS

During the year two first year Masters of Social Work students of Tata Institute of Social Science (TISS), six students of SNDT University, Social Work Department were placed for field work experience at IAPA Khetwadi and Matunga office.

One student was placed from Symbiosis College, Pune for block placement.

#### **FUND RAISING**

Fund raising has become an integral part of IAPA as with most not-for-profit organizations. With an expanded vision, our programmes and activities for development of children in need of care and protection have increased manifold. This has resulted in the need for augmenting funds to run the services effectively. Various fund raising activities were conducted during the year in addition to the constant support of our donors and sponsors.

On 28th February 2016, IAPA organized a Grand Fund Raising musical play titled 'Mere Piya Gaye Rangoon' directed by Mr. Sunil Shanbag.

IAPA also organized two Jumble sales in October 2015 and December 2015 and brought out Bookmarks and Bags made available against a donation.

#### MEMBERSHIP/ ACCREDITATION

#### Federation of Adoption Agencies (FAA) -

IAPA continued to be an active member of FAA which addresses concerns of its member adoption agencies.

**Credibility Alliance** – IAPA's accreditation under 'Desirable Norms' with Credibility Alliance continues.

**Newsletter** – This year due to paucity of funds only one edition of the Newsletter was published. Hence forth IAPA proposes to publish only e-newsletter with greater frequency.

**Visitors To The Office** – Mrs. Rita Steinau, President of Chance of Life (COL) along with Mrs. Claudia Sheiffer, Board member visited the organization on 10th October 2015 for the alumni meet of the sponsored students of Chance of Life. Ms. Dina Rosenmeier, Vice President of TdH, Denmark visited Khetwadi office on 23rd January 2016 and met some of the sponsored students.
